UNIT HEADQUARTERS QUOTA ENROLMENT RALLY: FOR AGNIVEER CAT AMC CENTRE & COLLEGE, LUCKNOW FROM 24 NOV TO 02 DEC 2023

- 1. AMC Centre & College UHQ Quota Enrolment Rally for the Rtg Yr 2023-24 for sons of Servicemen/Ex-Servicemen/War Widows/Widows and real brothers of serving personnel/ex-servicemen and son/brother of DSC personnel who have served in AMC for the vacancies of Agniveer Adm Assistant (Clerk), Agniveer Storekeeper Technical (SKT), Agniveer GD (Amb Asst & Dvr Mil Veh (DMV), Agniveer Tradesman 10th pass (Chef, Washerman, Steward, Dresser & Musician (open cat)) and Agniveer Tradesman 8th Pass (House keeper) is planned to be conducted at this Centre and College from 24 Nov to 02 Dec 2023. All eligible candidates will register themselves as per details given in para 2 below. The candidates are advised to report No 1 Mil Trg Bn Main Gate, next to AFMSD Personnel Line on the date intimated to them. Candidates reporting late or with incomplete documents will not be eligible to take part in rally.
- 2. To ensure smooth conduct of the Rect Rally as well as to prevent overcrowding, the following methodology will be adopted:-
 - (a) All aspirants will forward the scanned copy of the following documents correctly labelled, to the e-mail ID uhq2023@joinamc.com by 15 Oct 2023 for verification at this end:-
 - (i) Class 10th & 12th Education Mark Sheet and pass certificate.
 - (ii) Sponsorship Certificate as per Appendix 'A'.
 - (iii) Relationship Certificate issued by AMC Records/concerned Record Office.
 - (iv) Personal email id & mobile No of prospective candidate (Mobile No to be linked with Aadhaar).
 - (v) Aadhaar Card.
 - (vi) The e-mail subject heading should clearly state for which category the applicant has applied. A candidate cannot apply for more than one category.
 - (b) On verification of the ibid documents, a provisional acceptance e-mail with a registration Number will be sent to concerned aspirants on the e-mail id provided by the candidates. Specific reporting dates for screening in the rally will be intimated to individuals in the e-mail.
 - (c) Aspirants should report to this Centre (No 1 Mil Trg Bn Main Gate from Race Course Road through Shia Lines) on the date specified in the provisional acceptance e-mail. A printout of the acceptance e-mail will be carried by the candidates.
 - (d) Clarification, if any, may also be sought by sending a mail on the given e-mail id. The same will be sent as a **reply** to the e-mail message from AMC Centre & College (as trail mail) so that multiple separate e-mails are not recd from one candidate. Multiple e-mails from a candidate from same or different e-mail IDs will not be entertained.
 - (e) The original documents will be checked at the rally site and pre-screening is being undertaken only to restrict the No of candidates reporting per day for the rally in order to prevent overcrowding & ensure smooth conduct of the rally.
 - (f) Submission of application for registration at e-mail id uhq2023@joinamc.com will commence from 15 Sep 2023 and close on 15 Oct 2023.

3. <u>Terms and condition</u>. The salient aspects of terms and conditions of service for Agniveers enrolled through the Agnipath Scheme for service in the IA are mentioned in the succeeding paragrap. :-

(a) Enrolment.

- (i) Candidates will be enrolled under Army Act 1950 for a service duration of four (04) years including the training period.
- (ii) Agniveers so enrolled will be subject to Army Act, 1950 and will be liable to go wherever ordered, by land, sea or air.
- (iii) Agniveers enrolled under the scheme, will not be eligible for any kind of Pension or Gratuity.
- (iv) All aspects of terms and conditions of service for persons enrolled through the Agnipath Scheme for service in the IA are available on home page of www.joinindianarmy.nic.in.

(b) Service.

- Service of Agniveers will commence from the date of enrolment.
- (ii) Agniveers would form a distinct rank in the IA, different from any other existing ranks.
- (iii) Leave, uniform, Pay & allowances during the service pd of four years will be governed by orders and instructions in respect of such individuals issued by the Government of India (GoI) from time to time.
- (iv) Agniveers will be liable to be assigned any duty in organizational interest, as decided from time to time.
- (v) Personnel enrolled though Agniveer Scheme, will be required to undergo periodical medical check-ups and physicals/written/field tests as governed by orders issued. The performance so demonstrated would be considered for subsequent offer for enrolment in the Regular Cadre.
- (vi) Agniveers can be posted to any unit of Army Medical Corps (AMC) or any non-medical unit of Indian Army anywhere in the country and can be further transferred in organizational interest.

(c) Discharge.

- All Agniveers will be discharged on completion of four years of service.
- (ii) On discharge after completion of four years, Agniveers will be paid a "Seva Nidhi" package to enable them to return to the society for pursuing employment in the other sectors.
- (iii) Agniveers will not be eligible for any kind of pension or gratuity, neither will they be eligible for Ex Servicemen Contributory Health Scheme (ECHS), Canteen Stores Department (CSD) facilities, Ex servicemen status and other related benefits.
- (iv) Agniveers will be harred from disclosing classified information gained during service to any unauthorised person or source under Official Secrets Act 1923.

(d) Enrolment for Regular Cadre.

- (i) Based on organisational requirements and policies promulgated, Agniveers who are completing their engagement period in each batch will be offered an opportunity to apply for enrolment in the regular cadre of IA. These applications will be considered in a centralised manner by the army based on an objective criteria including performance during their engagement period and not more than 25% of each specific batch of Agniveers will be enrolled in regular cadre of the IA, post completion of their four years engagement period.
- (ii) Agniveers so enrolled as regular cadre would be required to serve for a further engagement period of 15 years and will be governed by terms and conditions of service (of Junior Commissioned Officer/Other Ranks in IA) currently in vogue (as amended from time to time). Agniveers will not have any right to be selected. Selection will be exclusive jurisdiction of the IA.
- (iii) With introduction of this scheme, the enrolment of soldiers in the regular cadre of IA, except technical cadres of Medical Branch, will be available only to those personnel who have completed their engagement period as Agniveer.

Employability.

- (a) Agniveers will be liable to be assigned any duty in organisational interest, as decided from time to time.
- (b) Agniveers can be posted to any unit of Army Medical Corps (AMC) or non-medical units of Indian Army and can be further transferred to other regiment/units in organisational interest.

5. Leave.

- (a) Annual Leave. Upto 30 days per year.
- (b) Sick Leave. Based on medical advice.

6. Pay, Allowances & Allied Benefits.

(a) Agniveer Package.

- (i) The pay & emoluments of Agniveers will be as given below:-
 - (aa) Year-1. Customised Package Rs 30,000/- (Plus applicable allowances)
 - (ab) Year-2. Customised Package Rs 33,000/- (Plus applicable allowances)
 - (ac) Year-3. Customised Package Rs 36,500/- (Plus applicable allowances)
 - (ad) Year-4. Customised Package Rs 40,000/- (Plus applicable allowances)
- (ii) From the above packages, 30% will be compulsorily deposited every month in a corpus which will be matched by the Government of India (GoI). Balance amount less the corpus contribution will be the in-hand component.

- (b) <u>Seva Nidhi Package</u>. On discharge at 4 years, the corpus of Rs 5.02 lakhs will be matched by the Government of India (GoI), an amount of Rs 10.04 lakhs and accrued interest will be given to the Agniveers. In case of Agniveers who are subsequently selected for enrolment in IA as regular cadre, the "Seva Nidhi" package to be paid to them will comprise only their contribution including accrued interest thereon. In the case of Agniveers exiting service before the end of their engagement period on their own request, the individuals Seva Nidhi package, accumulated as on date, will be paid with the applicable rate of interest. In such cases, no Govt contribution to Seva Nidhi Package will be entitled. The "Seva Nidhi" will be exempt from Income Tax.
- (c) <u>Payment Modality-Seva Nidhi Package</u>. Two options to receive Seva Nidhi package will be provided to each Agniveer, with an aim to provide financial loans for self employment/ entrepreneurship through a bank guarantee also to meet immediate/incidental expenses, on exit. Firm details will be promulgated separately.
- (d) <u>Allowances</u>. The Agniveer pay is a composite package and he will not be eligible for any Dearness Allowance and Military Service Pay. He will get applicable Risk & Hardship, Ration, Dress and Travel allowances as decided by the Government of India from time to time.
- (e) Agniveers will be exempted from making any contribution in Armed Forces Personnel Provident Fund or any other Provident Fund.
- (f) There shall be no entitlement towards gratuity or pensionary benefits for Agniveers enrolled through this scheme.
- 7. <u>Life Insurance Cover.</u> Agniveers will be provided non-contributory life insurance cover of Rs 48 lakhs for the duration of their engagement period and they will not be eligible for Army Group Insurance Fund (AGIF) schemes /benefits.

8. <u>Termination/Release from Service</u>,

- (a) The maximum period of service for Agniveers will be as enumerated at Para 3 (a) (i) above. However, the services of Agniveers under this scheme may be terminated at any time in accordance with the Army Act 1950.
- (b) Release at own request prior to completion of terms of engagement of Agniveers is not permitted. However, in most exceptional cases, personnel enrolled under this scheme may be released, if sanctioned by competent authority.
- 9. <u>Benefits for Personnel Exiting at Four Years of Service</u>. After completing four years of service (as applicable) the following benefits will be offered to the exiting individuals:-
 - (a) <u>Seva Nidhi Package</u>. Refer para 6 (b) above. The corpus generated after four years of contribution will be paid to the exiting Agniveers.
 - (b) Agniveer Skill Certificate. At the end of engagement period, a detailed skill set certificate will be provided to the Agniveers, highlighting the skills and level of competency acquired by the personnel during their engagement period.
 - (c) <u>Class 12th Certificate</u>. For Agniveers who have been enrolled after qualifying Class 10th, a certificate for 12th (equivalent) will be given on completion of their 4 years engagement period, based on skills attained.

Physical Measurement (At rally site)

Physical measurement will be carried out as per the Physical Standards.

Medical Test.

- (a) As per laid down medical standards at the Rally Site.
- (b) Unfit candidates will be referred to MH for specialist review. Candidates to report to designated Military Hospital within 5 days from referral and review medical exam to be completed by Military Hospital within 14 days as per policy.
- (c) Candidates made unfit at the dependent Military Hospitals will not be eligible for any further review.

Written Test through Common Entrance Examination (CEE).

- (a) CEE will be conducted for medically fit candidates at nominated venue. Date and Time of written test will be intimated at the rally site and through Admit Cards.
- (b) Admit Card for the CEE for the Rally Fit candidates will be issued at Rally Site itself.
- (c) Admit Card for the CEE for review Fit cases will be issued after getting modically Fit certificate from concerned specialist/specialists at Military Hospital.

- 15. <u>Docus Required</u>. Candidates are required to bring following documents/certificates in original alongwith two (02) x self attested photocopies with them to the rally site:-
 - (a) <u>Acceptance E-mail</u>. Printout of acceptance e-mail on good quality paper (Do not shrink the size).
 - (b) Affidavit. Affidavit will contain candidate's personal details to include name, father's name, address of residence (Permanent and present of last 5 years), caste, sub caste, religion, marriage status, statement of non-involvement in civil/criminal cases, no court case/ FIR pending against him in any Court of law. No part of the affidavit will be left blank. If not applicable, NA will be clearly written. The affidavit duly signed by the candidate on Rs 10/- Non Judicial stamp paper duly attested by Notary would be submitted by the candidate during the rally document check. If the candidate is below 18 yrs of age he should bring 'Consent Certificate' from his parents stating that they are willing for enrolment of their son in the Army & will not claim compensation for any injury caused during the entire rally. This affidavit should not be more than six (06) months old (Proforma of the affidavit is att as Appendix 'B').
 - (c) Relationship Certificate. Relationship Certificate issued from respective Record Office duly signed by Record Officer with Personal No, Rk, Name & Appt and with office round stamp must be recorded legibly in original. The Relationship Cert should bear 'WATER MARK' of concerned Records Office. Relationship Cert issued by DSC Records/any other agency will not be accepted (Auth: Dte Gen of Rtg letter No 62527/Rtg B (A) dt 14 Mar 2019). Relationship Cert will not be issued to any unattested rects & the same will not be valid.
 - (d) <u>Affidavit by Sponsor</u>. A declaration to the effect as mentioned in Affidavit on Ten Rupees Non-Judicial Stamp paper prepared by the candidate duly signed by 1st Class/Executive/Judicial Magistrate/Notary is required to be submitted by the candidate at the rally site (**Proforma att as Appendix 'C'**).
 - (e) <u>Discharge Book</u>. Original discharge book of Ex-Servicemen has also to be produced. Name and date of birth of the candidate must be recorded in it. The enrolling offr will return the original after attesting the photocopies. If the candidate fails to produce original Discharge Book at the rally site he will not **repeat** not be allowed to participate in the rally.
 - (f) Pension Book/PPO. In case sponsor is a Widow of Battle Casualty or in receipt of Special Family Pension/ Liberalized Family Pension/ is in receipt of disability pension more than 20% and disability is attributable/ aggravated by Military Service, the candidate shall bring Pension Book IN ORIGINAL alongwith 02 x photocopies duly self attested. The enrolling offr will return the original after attesting the photocopies. In case the candidate fails to produce original Pension Book/PPO at the rally site, he will not repeat not be allowed to participate in the rally.

(g) Education Certificates.

- (i) Education certificates with pass certificate and mark sheet of all educational qualifications achieved by candidate i.e Matric/Intermediate/Graduation etc from recognized School/Board/University.
- (ii) Provisional/online education certificate should be certified in ink & signed by the head of the educational institution of concerned Board/University.
- (iii) Candidates with matric certificate from Open School should bring School Leaving certificate countersigned by Block Education Officer/District Education Officer.
- (iv) Education certificates issued by Education Boards listed at Appendix 'D' will only be considered for screening.
- (h) <u>Character Certificate</u>. Character Certificate with family photo of all members incl name, relation & present occupation below the photographs alongwith official stamp affixed on it duly signed by the Village Sarpanch/Pradhan/Municial Corporator. <u>This certificate will be valid for six (06) months from the date of issue upto dispatch (Proforma att as Appendix 'E')</u>.
- (j) <u>Photographs</u>. Twenty (20) copies of latest good quality unattested passport size coloured photographs not more than 03 months old with white background will be required and all copies should be identical (<u>Photoshopped photos & Computer scanned & printed photographs will not be accepted</u>). Photographs must be with proper hair cut and clean shaven (except Sikh candidates). 10 copies are required for document checking & 10 copies for medical examination.
- (k) <u>School Character Certificate</u>. School Character Certificate issued by the School/College Principal/Headmaster where the candidate last studied.
- (I) <u>Body Tattoo Certificate</u>. As per Appendices mentioned in para 19 (b) (only in case of candidates with tattoos).
- (m) <u>Death Certificate</u>. Death Certificate issued by MH/Registrar of Births and Deaths in case Father/Brother is deceased.
- (n) <u>Single Bank A/C, PAN Card & Aadhaar Card</u>. Single Bank A/C, PAN Card & Aadhar Card are mandatory documents for final enrolment for purpose of Pay & allowances and other social benefits scheme (Not mandatory during rally screening except Aadhar Card which is mandatory for screening).

Provisional certificates will be accepted only during the notified rally duration neither earlier nor later.

(q) Sports Certificate.

- (i) Sportsmen who have represented India at International Level and State at National Level within the last two years (for list of sports under which relaxation in physical standards is admissible, attention is invited to www.joinindianarmy.nic.in website).
- (ii) Sportsmen who have represented District at State Level and University team or regional team at District Level within last two years (Sports certificate should be with registration number and from government recognized sport institutes/bodies).
- (iii) List of sports for enrolment is att as Appendix 'F'. (Auth :- Dte Gen of Rtg letter No 62541/Rtg B (A) dt 06 Jul 2020).

- (r) <u>Certificate of Bonus Marks</u>. All original certificates/photocopies duly attested pertaining to bonus marks will be accepted only during the rally. No certificates to include NCC/Sports/Relationship certificates or any other certificates to claim bonus marks/ relaxation would be accepted after termination of the rally.
- (s) Unmarried Certificate of candidates less than 21 yrs of age with photograph should be signed by village sarpanch/Pradhan/Ward Member. The certificate should not be more than six (06) months old (Proforma att as Appendix 'G').
- (t) Two Self addressed envelopes duly affixed with stamp of Rs 27/- each only.
- (u) Army auth will not be held responsible for any unfortunate injury, mishap or death caused to any candidate during the entire recruitment process including all kind of physical tests. - (ii) One son/ one legally adopted son of Ex-serviceman or one real brother (if the Ex-Serviceman is unmarried) in receipt of Disability Pension of 20% or more as revised wef Feb 2018 and the disability is attributed to/aggravated by Military Service.

(c) Priority-3 (Own Regt/Corps) (Serving/Ex-Serviceman)

- (i) One son of Servicemen/ Ex-Servicemen who died in harness to include legally adopted son whose death is not attributed to Military Service.
- (ii) One son of serving/ Ex Servicemen to include legally adopted son,
- (iii) One brother of Serviceman/ Ex-Serviceman.

(d) Priority-4 (Other Regt/Corps)

- (i) One son of war widow to include legally adopted son.
- (ii) Real brother of battle casualty who marries the widow of the Battle Casualty.
- (iii) One son-in-law of war widow having no son to include husband of legally adopted daughter.
- (iv) One real brother of unmarried battle casualty.

(e) Priority-5 (Other Regt/Corps)

- (i) As per priorities 2 & 3 above for own Regt/Corps to be implemented in respect of other Regt/ Corps in the same order/precedence.
- (ii) Wards of TA pers.
- 18. Individual is required to qualify in Physical Fitness Tests, Physical Measurement Tests, Medical Standards, Common Entrance Exam before the priority is taken into account and should come in merit for selection. If qualified, enrolment will be done subject to availability of vacancies & priority as given in para 17 above and on verification of documents produced by the indl.

19. Special Instructions.

- (a) 01 Oct 2023 will be taken as effective date of determining age eligibility for candidate. Candidates to produce 10th class/birth certificate at the time of preliminary document check during rally only.
- (b) <u>Body Tattoos</u>. Candidates belonging to tribal communities/from tribal areas, are permitted to have permanent body tattoos on any part of the body, as per existing customs and traditions of the said tribe to which a candidate belongs. - (e) Those not in possession of required documents will not be permitted to participate in the rally.
- (f) Candidates must carry their Aadhar Card as proof of identity. Candidates should ensure that Aadhar Card details are matching with details in the documents.
- (g) A Grievance Cell will be established at the rally site to address any grievances.
- (h) Candidates are requested to report at rally site with proper shaving and hair cut so as to ensure proper identification & medical review (except Sikh candidate).
- (j) Recruitment is purely based on merit list depending on available vacancies. Candidates do not have any right to claim recruitment in Army just on the basis of passing in the recruitment process.
- (k) <u>Touts</u>. In the past, a number of candidates have been found victims of touts, fake documents/impersonation and in the bargain have lost their candidature. Modus operandi/means used by the touts are as under:-
 - (i) Issue of fake PFT slips/impersonation during various stages of rally or conducting fake recruitment rallies.
 - (ii) Snatching/taking away original certificates from candidates who have been declared fit at initial stage and thereafter harassing them.
 - (iii) Taking away "Admit Card" from the candidates under plea that they will follow up their results.
 - (iv) Giving candidates false assurance of "Recruitment" as they claim to have links at appropriate level, thereby winning confidence of candidates.
 - (v) Once a candidate gets through on his own efforts, touts demand money in return of the original certificates.
- (I) Any candidate who has not received acceptance e-mail may approach Enrolling Offr on 1st day of rally at rally site with all original documents and **printout of initial e-mail sent by him on** e-mail id uhg2023@joinamc.com.

Important Instructions.

- 20. Candidates to come for the rally only on the date as per the acceptance email. Candidates should bring pen & handkerchief.
- 21. Selection is provisional till Enrolment Form/Rahdari Certificate is issued and candidates are dispatched for training.
- 22. Mobile phones & electronic gadgets are not permitted at the rally site and in CEE.

- 30. Matriculation Certificate/Birth Certificate of the candidates will be the deciding criteria for establishing "Date of Birth" to work out age factor.
- 31. It is reiterated that only one son/one real brother/ one legally adopted son will be eligible for enrolment under applicable priority of UHQ Quota Enrolment (Auth: IHQ of MoD (Army) letter No 62527/Rtg B (A) dt 20 Jul 2021).
- 32. If 180 days or more lapses between screening medical at the rally and despatch, medical will be done again and UNFIT candidates in this re-medical will not be recruited.
- 33. Any candidate producing fake documents and giving false info during enrolment will liable for termination of his service at any stage even after any number of yrs of service he renders.
- 34. <u>Use of Performance Enhancing Drugs</u>. Use of any kind of performance enhancing drugs is strictly banned. Candidates found to have used the same will be debarred from further screening.
- 35. Wards of civil employees who are paid out of Defence estimates, BSF, Air Force, Navy, GREF, Assam Rifles & MES are not permitted to attend the said recruitment rally.

- 46. The candidature of a candidate can be cancelled at any stage of the recruitment process at the discretion of the Enrolling Officer.
- 47. It is requested to disseminate the contents of this letter to all medical/ dental units under your jurisdiction.

<u>IMPORTANT NOTE</u>: It shall be the responsibility of each candidate to ensure that the relevant details as given in Relationship Certificate (Candidates Name, Fathers Name, Candidate's Date of Birth, Address) matches with corresponding details as given in Education Certificate/Marks Sheet, Mool Niwas and Police Verification.


