General Instructions

 The salient aspects of terms and conditions of service for persons enrolled through the Agnipath Scheme for service in the IA are mentioned in the succeeding paragraph.

2. Terms and Conditions.

(a) Enrolment.

- (i) Candidates will be enrolled under Army Act 1950 for a service duration of four (04) years including the training period.
- (ii) Agniveers so enrolled will be subject to Army Act 1950 and will be liable to go wherever ordered, by land, sea or air.
- (iii) Agniveers enrolled under the scheme, will not be eligible for any kind of Pension or Gratuity.

(b) Service.

- Service of Agniveers will commence from the date of enrolment.
- (ii) Agniveers would form a distinct rank in the Indian Army (IA), different from any other existing ranks.
- (iii) Leave, uniform, pay and allowances during the service period of four years will be governed by orders and instructions in respect of such individuals issued by the Government of India (GOI) from time to time.



- (iv) Agniveers will be liable to be assigned any duty in organisational interest, as decided from time to time.
- (v) Personnel enrolled through Agniveers Scheme, will be required to undergo periodical medical check-ups and physical/written/field tests as governed by orders issued. The performance so demonstrated would be considered for subsequent offer for enrolment in the Regular Cadre.
- (vi) Agniveers can be posted to any regiment/ unit and can be further transferred in organisational interest.

(c) <u>Discharge</u>.

- (i) All Agniveers will be discharged on completion of four years of service.
- (ii) On discharge after completion of four years, Agniveers will be paid a 'Seva Nidhi' package.
- (iii) Agniveers will not be eligible for any kind of pension or gratuity, neither will they be eligible for Ex-Servicemen Contributory Health Scheme (ECHS), Canteen Stores Department (CSD) facilities, Ex Servicemen status and other related benefits.
- (iv) Agniveers will be barred from disclosing classified information gained during service to any unauthorised person or sources under Official Secret Act, 1923.

(d) Enrolment for Regular Cadre.

- (i) Based on organisational requirements and policies promulgated Agniveers who are completing their engagement period in each batch will be offered opportunity to apply for enrolment in the regular cadre of IA. These applications will be considered in a centralised manner by the army based on an objective criteria including performance during their engagement period and not more than 25% of each specific batch of Agniveers will be enrolled in regular cadre of the IA, post completion of their four years engagement period.
- (ii) Agniveers so enrolled as regular cadre would be required to serve for a further engagement period of 15 years and will be governed by terms and conditions of service (of Junior Commissioned Officers/ Other Ranks in IA) currently in vogue (as amended from time to time). Agniveers will not have any right to be selected. Selection will be exclusive jurisdiction of the IA.
- (iii) With introduction of this scheme, the enrolment of soldiers in the regular cadre of IA, except technical cadre of Medical Branch, will be available only to those personnel who have completed their engagement period as Agniveer.

Eligibility. Following will be applicable:-

(a) Age Limit. The age limit for the applicants will be from 17 ½ years to 21 years.

1°t day of the month of Oct of recruiting year (01 Apr - 31 Mar) will be taken as effective date for determining the age eligibility for the candidates. The recruitment will be on All India All Class (AIAC) basis.

- 4. <u>Enrolment</u>. As part of enrolment process, each Agniveer will be required to formally accept all terms and conditions of the Agnipath Scheme. For personnel below the age of 18 years, the enrolment form will need to be signed by the parents/ guardians, in accordance with extant provisions.
- Training. On being enrolled, candidates will be imparted suitable military training based on organisational requirements.
- Allotment of Service Numbers. Distinctive Service Numbers will be allotted to Agniveers for the duration of their Service.

Employability.

- (a) Agniveers will be liable to be assigned any duty in organisational interest, as decided from time to time.
- (b) Agniveers can be posted to any regiment/unit and can be further transferred to other regiments/units in organisational interest.



- 8. <u>Leave</u>. Grant of leave will be subject to exigencies of service. The following leave will be applicable for Agniveers during their engagement period:-
 - (a) Annual Leave. Upto 30 days per year.
 - (b) Sick Leave. Based on medical advice.
- Uniform. A distinctive insignia will be worn by the Agniveers on their uniform during their service period. Detailed instructions shall be issued separately.
- Honours & Awards. Agniveers will be entitled to honours and awards, as per extant guidelines governing in the subject for Indian Army.
- Medical & CSD Facilities. For the duration of their engagement period in the Indian Army, Agniveers will be entitled for medical facility at Military Hospitals as well as CSD provisions.

12. Pay, Allowances and Allied Benefits.

- (a) Pay & Allowances. Agniveer enrolled under this scheme will be paid an Agniveer package with a fixed yearly increment. In addition, Risk and Hardship allowances (as applicable in Indian Army), Dress and Travel allowances will be paid.
- (b) Terminal Benefits Seva Nidhi Package Agniveer will be given onetime 'Seva Nidhi' package comprising their monthly contribution with matching contribution by the Government on completion of their engagement period, as indicated below:-

- Note 1. Agniveer will not be required to contribute to any Provident Fund of the Government.
- Note 2. There shall be no entitlement to any gratuity and any kind of pensionary benefits in the case of Agniveer.
- (c) Payment Modality Seva Nidhi Package. Two options to receive Seva Nidhi package will be provided to each Agniveer, with an aim to provide financial loans for self-employment/ entrepreneurship through a bank guarantee as also to meet immediate/ incidental expenses, on exit. Firm details will be promulgated separately.



- (d) <u>Allowances</u>. The Agniveers pay is a composite package and he will not be eligible for any Dearness Allowance and Military Service Pay. He will get applicable risk and hardship, ration, dress and travel allowances as decided by the Govt of India (GOI) from time to time.
- (e) <u>Provident Fund</u>. Agniveers will be exempted from making any contribution in Armed Forces Personnel Provident Fund or any other Provident Fund.
- (f) <u>Gratuity/ Pension</u>. There shall be no entitlement towards gratuity or pensionary benefits for Agniveers enrolled through this scheme.
- Life Insurance Cover. Agniveers will be provided non-contributory life insurance cover of Rs 48 lakhs for the duration of their engagement period and they will not be eligible for Army Group Insurance Fund (AGIF) schemes/benefits.

14. Termination/ Release from Service.

- (a) The maximum period of service for Agniveers will be as enumerated at Para 2 above. However, the service of Agniveers under this scheme may be terminated at any time in accordance with the Army Act 1950.
- (b) Release at own request prior to completion of terms of engagement of Agniveers is not permitted. However, in most exceptional cases, personnel enrolled under this scheme may be released, if sanctioned by the competent authority.
- 15. <u>Compensation for Death</u>. Agniveers will not be governed by provisions contained in the Pension Regulations for Army (as amended from time to time). They would be suitably compensated for death. The death for the purpose of provision of financial benefits to Agniveers will be categorised as follows:-
 - (a) Category X. Death due to natural causes neither attributable to nor aggravated by military service.
 - (b) <u>Category Y</u>. Death due to cause which are accepted as attributable to or aggravated by military service or due to accidents/ mishaps in the performance of duties including training.
 - (c) <u>Category Z</u> Death due to acts of violence/ attacks by terrorists, anti social elements, enemy, during border skirmishes/ war/ peacekeeping operations/ aid to civil power etc, and during operational preparation and training for war including battle inoculation training/ exercises; and accidental deaths due to natural calamities/ operations specially notified by Gol etc.
- 16. Compensation for Disability. In case an individual is placed in a Permanent Low Medical Category (LMC), the authorities will assess the percentage of disability/ attributability. In case of disability (attributed/aggravated due to service conditions), one time ex-gratia as mentioned below will be granted. Computation of extent of disability will be as under:-

- 18. Benefits for Personnel Exiting at Four Years of Service. After completing four years of service (as applicable). The following benefits will be offered to the exiting individuals:-
 - (a) Seva Nidhi Package. Refer Para 5(b) above. The corpus generated after four years of contribution will be paid to the exiting Agniveers.
 - (b) 'Agniveer' Skill Certificate. At the end of engagement period, a detailed skill set certificate will be provided to the Agniveers, highlighting the skills and level of competency acquired by the personnel during their engagement period.
 - (c) Class 12th Certificate. Agniveers who have been enrolled after qualifying Class 10th, a certificate for 12th (equivalent) will be given on completion of their 4 years engagement period, based on skills attained. Detailed instructions shall be issued separately.

- 22. Relationship Criteria. Unit Headquarters Quota (UHQ) recruitment is applicable for only One Son/ One real Brother of Servicemen/ Ex-Servicemen. Original Relationship Certificate issued by concerned Records Office with watermark of issuing Record Office is mandatory for enrolment under UHQ. Relaxation in physical criteria and Bonus Marks is applicable in case of son of Serviceman/Ex-Serviceman only. If the Relationship Certificate has also been issued to brother (s) of the candidate and not utilised, then the candidate shall bring the Original Ink Signed copy of the relationship certificate issued to his brother (s).
- 23. <u>Instant Enrolment of Wards of Battle Casualties</u>. The wards of Battle Casualty will be provided instant enrolment as per laid down guidelines of Recruitment Directive for recruitment of JCOs & OR - 2014. Conditions for instant enrolment are as under:-
 - (a) One real son of deceased soldier/battle casualty. It does not include legally adopted son (In case the son is born after the death of Army personnel and Part II order was not published, the widow should submit an Affidavit from Class I Judicial Magistrate and a certificate from the Local Zila Sainik Board duly authenticating the birth of the son).

OR

(b) One real brother of Battle Casualty as per service document (If the deceased soldier/battle casualty was unmarried/issueless or had no male child) who died in war or war like situation during peace time (like CI Ops or while providing aid to civil auth).

OR

- (c) One real son of the Battle Casualty invalided out of service on medical ground.
- 24. Priority. Recruitment under Unit HQ Quota is purely based on priority as enumerated below:-
 - (a) Priority-1: Battle Casualty/Liberalized Family Pension (Corps of EME)
 - One son of war widow in receipt of liberalized family pension to include legally adopted son.
 - (ii) Real brother of battle casualty who marries the widow of the battle casualty.



- (iii) One son-in-law of battle casualty having no son to include husband of legally adopted daughter.
- (iv) One real brother of unmarried battle casualty.

(b) Priority - 2 : Disability Pensioners/Special Family Pensioners (Corps of EME)

- (i) In respect of servicemen who die in harness, one son/one legally adopted son or one real brother (if the serviceman is unmarried) where the widow/NOK is in receipt of special family pension.
- (ii) One son/one legally adopted son of Ex-servicemen or one real brother (if the Ex-servicemen is unmarried) in receipt of disability pension of 20% or more as revised with effect from Feb 2018 and the disability is attributed to/aggravated by military service.

(c) Priority - 3 : Serving/Ex-Serviceman (Corps of EME).

- One son of serviceman who dies in harness to include legally adopted son whose death is not attributed to military service.
- (ii) One son of serving/Ex-serviceman to include legally adopted son.
- (iii) One brother of serviceman/Ex-serviceman.

(d) Priority - 4 : Other Regiment/Corps.

- (i) One son of war widow to include legally adopted son.
- (ii) Real brother of battle casualty who marries the widow.
- (iii) One son-in-Law of war widow having no son to include husband of legally adopted daughter.
- (iv) One real brother of unmarried battle casualty.

(e) Priority -5: Other Regiment/Corps.

- (i) In respect of servicemen who die in harness, one son/one legally adopted son or one real brother (If the serviceman is unmarried) where the widow/NOK is in receipt of special family pension.
- (ii) One son/one legally adopted son of Ex-serviceman or one real brother (if the Ex-serviceman is unmarried) in receipt of disability pension of 20% or more and the disability attributed to/aggravated by military service.
- (iii) One son of serviceman who dies in harness to include legally adopted son whose death is not attributed to military service.
- (iv) One son of serving/Ex-serviceman to include legally adopted son.
- (v) One brother of serviceman/Ex-serviceman.
- (vi) Wards of TA Bn.
- 25. Qualitative Requirements. Present Qualitative Requirement (QR) in terms of physical standards, relaxation in physical standards, education standards and physical fitness test for Unit HQ Quota enrolment are attached at Appendix 'A'.

- 26. Reporting. Candidates to report to 3 EME Centre, Bhopal as per schedule given at Para 19 (*T' Junction, 3 EME Centre, Bairagarh, Bhopal) alongwith documents and certificates mentioned in succeeding paragraphs, in original along with two additional photocopies duly self-attested for registration/documentation formalities.
- Documents. Candidates are required to bring following documents/ certificates in original with two attested photocopies with them to the rally site:-
 - (a) <u>Photographs</u>. Twenty (20) copies of unattested passport size colour photographs developed in good quality photographic in white background not more than three months old. <u>Computerised/ photocopied/ shopped photograph will not be accepted</u>.  - (ii) A declaration to the effect as mentioned in Affidavit on Ten Rupees Non-Judicial Stamp Paper prepared by ESM duly signed by 1st Class/ Executive/ Judicial Magistrate is required to be submitted by the candidate at rally site. Format is attached as per Appendix 'D'.
 - (iii) Original Discharge Book of Ex-Servicemen also to be produced. Name and date of birth of the candidate must have been recorded in it.
- (j) NCC Certificate. NCC A/B/C certificate and Republic Day Parade certificates should have photograph of the candidate duly attested by issuing authority. Provisional NCC A/B/C pass certificates will only be accepted if authenticated by concerned NCC Group Commander. No bonus marks will be allotted unless the certificates (Relationship/ Sports/ NCC) have been verified. An undertaking to the effect will be obtained from the candidate (As per the Performa att as Appendix 'E'). Provisional certificates are accepted only during the notified rally duration neither earlier nor later.

(k) Sports Certificate.

- Sportsmen who have represented India at International level and State at National level within the last two years.
- (ii) Sportsmen who have represented District at State level and University team or Regional team at District level with 1st/2nd position within last two years (Sports Certificate should be with registration number and from government recognised sport institutes/bodies).
- (iii) <u>List of Sports</u>. For list of sports under which relaxation in physical standards is admissible, attention is invited to <u>www.joinindianarmy.nic.in</u> website. List of Sports for enrolment is attached as **Appendix 'F'**.

(iv) Following Sports Certificates Will Not Be Accepted:

- Sports promotion participation certificate issued by various organisers/entities under/various Ministries but not part of the recognised sports federations.
- (ii) Zonal/Regional level certificates.
- (iii) Registered societies not recognised.
- (iv) Certificates issued by various Ministries at National/State level other than the Sports Ministry recognised federations at National/State Level.



- (v) Talent hunt tournaments.
- (vi) City marathon/cycling/other sports events sponsored by corporate or other such agencies.
- (i) Affidavit. Duly signed by candidate on Rs 10/- non judicial stamp paper as per specimen duly attested by notary will be submitted by the candidate at the rally site without fail. Format of Affidavit attached as per Appendix 'G'. Submission of Affidavit is mandatory to gain entry into the rally. Candidates WILL NOT BE PERMITTED to enter the rally without affidavit.
- (m) <u>Certificate of Bonus Marks</u>. All original certificates/ photocopies duly attested pertaining to Bonus Marks will be accepted only during the Rally. No certificates to include NCC Certificates, Sports Certificates, Relationship Certificate or any other certificate to claim Bonus Marks/ Relaxation would be accepted after termination of the Rally.
- (n) <u>Single Bank Account/ PAN Card & AADHAR Card</u>. Single Bank Account, PAN Card & Aadhar Card are mandatory documents for final enrolment for purpose of Pay & allowances and other social benefits scheme.
- (o) Police Character Certificate as per the Performa att as Appendix 'H'.
- (p) Sarpanch/ Nagar Sewak (Residence Proof) as per the Performa att as Appendix 'J'.
- (q) Character/ Pre-verification Certificate. Family photo of all members with name, relation and present occupation below the photographs. The certificate should be attested and also verified by the village Sarpanch/ Pradhan/ Ward Member with his stamp affixed on the both side of character/pre-verification certificate. Serving father/ brother of the candidate in the photograph will be in uniform. No mixing/ patches in photograph will be accepted. Validity of the same is six months from the date of issue (Performa is as per Appendix 'K' attached).
- (r) <u>Serving Certificate</u>. Serving Certificate of sponsorer with photograph (of serving soldier) duly attested, and countersigned by OC/CO Unit, if father/ brother of the candidate is a serving soldier (Performa is as per Appendix 'L' attached).
- (s) Sponsorship Cert. As per present policy, a serviceman/ ex-serviceman can avail sponsorship facility for one real son/brother only. Hence, an affidavit by the sponsoring individual to this effect that he has not availed sponsorship facility earlier throughout his life for any other son/ real brother (as applicable) will be submitted. The affidavit will be made on Rs. 10/- non judicial stamp paper in English with photograph duly attested. It will be signed by Executive Magistrate Class-I/ SDM/ Tehsildar/ Notary duly affixing his name bearing rubber stamp and office stamp (Performa is as per Appendix 'M' attached).
- (t) Correctness of Information Cert. As per present policy, only genuine and eligible candidates can apply for enrolment in Army being wards and brother of serviceman/ex-serviceman. In addition, an affidavit will be made on Rs. 10/- non judicial stamp paper in English with photograph duly attested. It will be signed by Executive Magistrate CI-I/SDM/ Tehsildar/ Notary duly affixed his name bearing rubber stamp and office stamp (Performa is as per Appendix 'N' attached).



(u) <u>Drug Abuse</u>. An indemnity bond to this effect that candidate participating in the recruitment rally has not used any means of physical performance enhancing drugs during recruitment rally, duly signed by the candidate will be submitted at the rally site prior to physical fitness test. Format attached at Appendix 'O'.

29. Special Instructions

- (a) <u>Decorum</u>. At the rally site, all candidates should report duly shaved (beard, chest hair, auxiliary hair, pubic hair and with crew hair cut (except Sikh Candidates), for identification at various stages of rally process failing which candidate can be barred from participation in recruitment rally.
- (b) <u>Aadhar, Email ID and Mobile Number</u>. Candidates will submit 02 x selfattested copies of Aadhar, e-mail ID and mobile number.
- (c) Candidate's Name/Father's Name/Mother's Name. The particulars of name of the father, name of the mother and date of birth listed in 10th class certificate will be taken as final for the purpose of enrolment. In case of individual's name, father's name/mothers' name, surname (Spelling variation may be accepted as long as the name remains the same. Similarly when the surname has been included in one certificate but not included in the other, it may also be accepted as long as the name is same. In no case, an entirely different name in one of the certificate be accepted) as shown on the 10th class vis-a-vis relationship will need to be established. Affidavit on a Rs 10/- non judicial stamp paper duly countersigned by the Executive Magistrate Class-I/Notary is required (Performa is as per Appendix 'AA' attached) with name bearing rubber stamp and office round stamp. The affidavit will be submitted by the father of the individual or mother in case of widow.



- (d) <u>Touts</u>. In the past, a number of candidates have been found victim of touts, fake, documents/ impersonation and in the bargain have lost their candidature, Modus operandi/ means used by the touts are as under:-
 - Issue of fake PFT Slips/ Impersonation during various stages of rally.
 Conduct fake recruitment rallies.
 - Snatching/ taking away original certificates from candidates who have been declared fit at initial stage and thereafter harassing them.
 - (iii) Taking away "Admit Card" from the candidates under plea that they will follow up their results.
 - (iv) Giving candidates false assurance of "RECRUITMENT" as they claim to have links at appropriate level, thereby winning confidence of candidates.
 - (v) Once a candidate gets through on his own efforts, touts demand money in return of the original certificates.
- (e) For 8th Class Pass Candidates. 8th class pass marks sheet and transfer certificate issued by school (both certificate) should be countersigned by District Inspector of School/District Education Officer.
- (f) <u>Grievance Cell</u>. A Grievance Cell will be established at Rally Site to redress any grievances.
- (g) Recruitment is purely based on merit list depending on available vacancies. Candidates do not have any right to claim recruitment in Army just for passing in recruitment process.
- (h) Selection is provisional till Enrolment Form/ Contract/ Rahdari Certificate is issued and candidates are despatched for training.
- Mobile phones and other electronic/ digital communication devices are not permitted in the rally site and during Common Entrance Exam (CEE).
- (k) Candidates are advised in their own interest to undergo medical exam before coming for selection especially with respect to flat foot, poor vision, deformities and physical measurements. All are advised to ensure that their ears are free of wax by getting it cleaned by a doctor prior to the rally.
- (I) CEE for the selected candidates will be held tentatively on 09 Mar 2025. Negative marking will be applicable in CEE.
- (m) Candidates may have to present themselves at rally site for two to three times. Candidates should make arrangements for stay under their own arrangements.
- (n) The complete process of recruiting at this Centre is absolutely transparent/fair with different set of assessors/examiner for different stage of selection/screening and candidates must have faith in their abilities.
- (o) Contact Lenses. Use of contact lenses is not allowed.



- (p) All photocopy of documents submitted by the candidate (s) will be self attested with name, date and time.
- (q) Affidavits given at appendices to be produced by each candidate and each page should be signed by the candidate.

30. Important Instructions.

- (a) <u>Discharge Book</u>. In case candidate is Son/ Brother of Ex-servicemen, he shall produce discharge book in original duly highlighting complete details of family members including himself. In case the candidate fails to produce original discharge book at the rally site, he may not repeat not be allowed to participate in the rally.
- (b) Pension Book/ PPO. In case sponsor is a widow of battle casualty or in receipt of special family pension/liberalized family pension/ is in receipt of disability pension more than 20% and disability is attributable/ aggravated by military service. The candidate shall bring pension book/ PPO IN ORIGINAL. In case the candidate fails to produce original pension book at the rally site, he may NOT repeat NOT be allowed to participate in the rally.
- (c) ITI/ NTC Certificate. ITI/ NTC (National Trade Certificate) certificate from institutes which are set up under Directorate General of Training (DGT), Ministry of Skill Development & Entrepreneurship (MOSDE), Government of India will be considered for bonus marks after verification. These training institutes are Government run training organisations and private Industrial Training Centres. These institutes are affiliated to National Council for Vocational Training (NCVT) and run by programme under Craftsman Training Scheme.
- (d). Consent Certificate. Candidate below 18 yrs of age should bring 'Consent Certificate' from their parents stating that they are willing for enrolment of their son in the Army and will not claim for compensation for any injury caused during screening (Refer Para 1 (f) of Appendix 'G').

(e) Body Tattoos

- (i) Candidates belonging to tribal communities/ from tribal areas, are permitted to have permanent body tattoos on any part of the body, as per existing customs and traditions of the said tribe to which a candidate belongs. Such candidates will only be permitted on producing the following two certificates:-
 - (aa) Self declaration certificate to be signed by the candidate is attached as Appendix 'AB'.
 - (ab) Certificate of belonging to a tribal community and permissibility of permanent Body Tattoo(s) to be signed by DC/DM or SDM of the District/ Tehsil where the tribe of the candidates is presently settled is attached as Appendix 'AC' (Name and designation of the concerned official must be clearly mentioned).



- (ac) Permanent body tattoos of religious sentiment are only permitted on inner face of forearms i.e from inside of elbow to the wrist and on the reverse side of palm/ back (dorsal) side of hand. Permanent body tattoos on any other part of the body are not acceptable and candidates will be barred from further selection.
- (f) Personal Details, Nativity and Caste/Sub Caste. Personal details (i.e name of father, mother, candidate & date of birth) will be filled up as per Class 10th (Matriculation Certificate). Details of home address as per nativity (Mool Niwas) and caste/sub caste as per caste certificate of candidate should be endorsed on all documents and affidavits (except serving certificate of sponsor).
- (g) Variation in Date of Birth. A variation of upto 366 days in date of birth recorded in the official records and the education certificate (10th Class/ Metric) of the candidates will be taken as a minor variation and considered for enrolment. Any variation beyond 366 days will be treated as major variation and such candidate will not be considered for UHQ enrolment. Affidavit on Rs 10/- non judicial stamp paper duly countersigned by the Executive Magistrate Class-I/Notary is required (Appendix 'AA') with name bearing rubber stamp and office round stamp.
- (h) Ambiguity in Date of Birth Mentioned in Relationship Certificate. Ambiguity in date of birth mentioned in relationship certificate (for example Date of birth mentioned as "Candidate was 08 years at the time of enrolment of his brother" etc) will not be accepted. Date of Birth of candidate should be mentioned clearly in figures (i.e DD.MM.YYYY format in Relationship Certificate). Correct mentioning of date of birth in Relationship Certificate of son/brother of servicemen &son/brother of Ex-servicemen is an inescapable and mandatory requirement for enrolment in the Army. Candidate shall be entertained at recruitment rally site only on producing correct Relationship Certificate (duly highlighting the correct Date of Birth in figures).
- (j) Variation in Residential Address Between Nativity Certificate and Relationship Certificate. Nativity/domicile/mool niwas certificate is the primary document for residential address. All subsequent address verifications will be based on this certificate and address mentioned in caste certificate, affidavits and other certificates/documents should be as per nativity/domicile/mool niwas certificate of a candidate. Alongside nativity certificate, all candidates should clearly mention their places of residence in the last five years at Para 1 (b) (iv) of Appendix 'G'.
- (k) Affidavit for Non Involvement in Banned Political Organisation and No Criminal Case. The candidate will submit an affidavit that he had or have not been a member of any banned/ political organisation and have never been in custody/jail and no criminal or judicial case is pending against him in any court of law in India/ abroad. That he has not been ever convicted for any offence under the Law. Format attached at Appendix 'AD'.
- (I) A candidate will be permitted entry into the rally site only on producing of Relationship Certificate, Education Certificate (Including 10th Class) and affidavit. Anyone found with fake documents will be handed over to Civil Police.
- (m) All candidates must clean their ears and remain medically fit before coming for recruitment.



- (n) Army authorities are not responsible for any injury, death or loss of academic session caused to any candidate during recruitment process. Candidates will participate at their own risk. Boarding/lodging facility is not available within 3 EME Centre, Bhopal. All candidates will have to make their own arrangement during the conduct of entire recruitment rally and must take care of their documents/belongings against theft.
- (o) No journey fare will be admissible to the candidates appearing in the recruitment rally.
- (p) Wards of Civil Employees who are paid out of Defence estimates, BSF, Air Force, Navy, GREF, Assam Rifles and MES are NOT permitted to attend the said recruitment rally.
- (q) All personnel taking part in Common Entrance Exam (CEE) will deposit one self addressed registered envelope along with requisite postage stamps.
- (r) <u>Footwear</u>. 1.6 Km run may take place on Road/ Hard surface due to weather condition. All candidates are advised to use suitable running (shoes) for 1.6 Km run and practice accordingly for the rally.
- (s) Rallies may take place during winter months, candidates are advised to practice accordingly for the rally.

31. General Guidelines Against Malpractices.

- (a) Recruitment is a free service and candidates are cautioned against falling victims to unscrupulous agents/middlemen/touts. Candidates are warned not to pay any money to any such touts or make any kind of favourable arrangement with them as there is no way that they can influence recruiting process at 3 EME Centre, Bhopal.
- (b) Production of bogus/fake certificates and indulging in unfair means is a criminal offence and liable for punishment under law.
- (c) Candidates are also warned NOT to handover original documents/certificates to agents/middlemen/touts as they will only mislead. Any involvements with touts will render the candidature null and void.
- (d) Certificate with overwriting and tampering of seals or erasing/alteration of any type will not be accepted.
- (e) In case candidates come across any such touts/agents/middlemen, the same must be immediately brought to the notice of the authorities at this 3 EME Centre, Bhopal.
- (f) No candidate will make any effort to contact any combatant and vice versa. No candidate is allowed to stay in the family quarters of staff posted in the 3 EME Centre, Bhopal even if he is a relative. Candidature of such cases will be cancelled.
- (g) Candidates will produce original documents for relaxation into enrolment like Relationship Certificate, NCC (A/B/C) and Sports at the time of Recruit Master Data Sheet (RMDS) feeding (between 29 Jan to 08 Feb 2025 tentatively) in software. After Recruit Master Data Sheet (RMDS) verification by the Presiding Officer no such documents will be accepted. Certificates with overwriting or tampering of seals or erasing of any type and of provisional nature will not be accepted.



- Candidates found not having the above mentioned certificates/having only provisional certificate will be rejected from the rally site itself. Malpractices and attempted enrolment by producing fake certificates during the rally will call for disciplinary action against the defaulter by the civil police. Candidates who produce fake certificates will be handed over to the civil police.
- Misrepresentation of facts/concealment of any information if detected at any stage of recruitment process will lead to the cancellation of candidature of defaulters. Producing fake documents & giving false info will make the candidate liable for terminating of service despite any number of years' service that may be rendered.
- The place for recruitment is out of bound for all ranks. (k)
- Army enrolment being a central government organisation, all documents are required to be in English or Hindi language only. Candidates with certificates in state languages will produce a translated true copy of certificate without fail.
