- (b) deaf and hard of hearing (HI-Hearing Impaired);
- (c) locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy (01- Orthopedically Impaired).

- "The Electronics & Information Technology Department vide notification no. 435 dated 08.02.2021, has notified that the OS-CIT course of Odisha Knowledge Corporation Limited (OKCL) and 0 level course of National Institute of Electronics & Information Technology (NIELIT) certify basic computer proficiency as the course covers foundation-level knowledge in computer application. 0 level certificate is issued by NIELIT and the course is given by training institutions accredited with NIELIT which can be verified from their portal (www,nielit goy in)".
- "Other higher courses such DCA, BCA, PGDCA, MCA, etc. typically lay emphasis on subjects like Database Management System, Operating System, Software Engineering, Computer Architecture, Web Technology, Multimedia and Languages such as C++, JAVA, etc. and are suitable for employment as

Programmer, Systems Analyst, Database Administrator, etc. All these courses need to be certified by Central Universities/ State Universities/ Deemed Universities/ State Private Universities whose list finds place in the Universities Grants Commission portal (wvw.mgc ac in) or by All India Council for Technical Education (vvww.aicte-irda.orii) or SCTEVT (sctevtodisha.nic.in)".

- Computer proficiency is only qualifying in nature and shall not count for determining the order-of-merit
 - B) Age Limit: (i) A candidate must have attended the age of 18 Years & must not be above 40 years as on date- 01.10.2024 (on the 1st day of the month during which the recruitment process starts viz. calling of application starts). Date of birth as recorded in the HSC certificate issued by the Board of Secondary Education, Odisha or equivalent certificate issued by any recognized Board/ Council/ Indian University shall only be accepted.

(ii) Relaxation of upper age limit: -
